## 11.1.49 <u>WELWITCHIA HEALTH TRAINING CENTRE - FEEDBACK ON HEIGHT</u> RESTRICTION

(C/M 2022/01/27 - E 3342)

In- Camera Special Management Committee Meeting of 25 January 2022, Addendum 8.2 page 00 refers.

## A. The following item was submitted to the Management Committee for consideration:

#### 1. Purpose

The purpose of this submission is to provide feedback to Council on the proposal submitted to Messrs Welwitchia Health Training Centre (WHTC), who was awarded the bid to establish a tertiary institution on erf 3342, on the height restrictions.

Council took a decision on the 30 September 2021 under item 11.1.31

- (a) That Council takes note of the request by Messrs Welwitchia Health Training Centre, to retain the height restriction of 40m as per their letter dated 24 August 2021.
- (b) That Council does not approve a height restriction of 40m for the development of a tertiary institution on Erf 3342, Extension 9, but rather approves a height restriction of 20m. This height restriction to include architectural features as well.

The above Council decision was communicated to Messrs WHTC on the 01 November 2021 (Annexure A). Messrs WHTC submitted a response letter dated 10 October 2021 (Annexure B), requesting that Council rather considers a hight of 28 m instead of the 20m that was decided under Council resolution of 30 September 2021 under item 11.1.31. In order to limit the back and forth of letters, a meeting was scheduled on the 22 November 2021 (Annexure C) to discuss Council's position and to look at various options which will benefit both parties.

On the **21 January 2022**, a letter (**Annexure D**) was received from Messrs WHTC agreeing to the 20 m height restriction for the development.

#### B. After the matter was considered, the following was:-

#### RECOMMENDED:

- (a) That Council takes note of the response by Messrs Welwitchia Health Training Centre, agreeing to the 24m height restriction as proposed under Council resolution of 30 September 2021 under item 11.1.31.
- (b) That General Manager: Corporate Services and Human Capital, commences with the development agreement immediately.
- (c) That Messrs Welwitchia Health Training Centre submits an infrastructure impact study which deals with the impact that their proposed development will have on the Municipal services such as the water, sewer, road / traffic, semi-purified, parking arrangements etc. to the General Manager: Engineering and Planning Services.

IDP Engineering Consultancy is the appointed Lead consultant by WHTC for their prestigious university project in Swakopmund, Namibia. On behalf of WHTC we have approached earlier to the honorable committee for reconsideration in the latest revision in height limits.

As a designer, our vision is to ensure more efficient and sustainable utilization of allotted land ensuring multipurpose use of BUA for various functions while considering the more effective enforcement of authority regulations.

Therefore, after careful consideration for by laws and especially height limit and as requested earlier; we are hereby explaining our vision of university concept and the essential need of availability of height provision as follows:

- 1. We have designed this university project on the basis of received invitation for development proposal from tertiary (Notice No: 57/2020 Appendix C on November 2020) stating maximum allowable height of 40m. Please refer to attachment (1-Height Reference 2.3 A page 14/18).
- 2. The university Architectural concept reflects the compactness and integration of latest technology with a futuristic approach to develop a contemporary learning environment for the provisions of barrier free environment.
- 3. Our current concept design is a paradigm shift in a standard university design approach. It's based on staggered building design heights in a constructive sense, to consider all possibilities and advantage to shape up the maximum use of climatological energy harvesting while deploying as little material as possible. This pertains to the buildings' shape, their directional airflow, lighting and the required orientation of façade giving the maximum exposure of building roofs to the sun path harvesting the maximum solar energy possible along with the efficient integration of daylight for a better well-being in built environment enriching the cognitive learning skills of students.



This sustainable design approach allowed for approximate height of 28 m at the highest point of college building, including the Architectural features at the top (Roof integrated photovoltaic cells) which is essential to achieve the design vision.

Accordingly, we kindly request you to approve the height of 28 m of the current design to avoid the concept design clashes and abortiveness and allow us to continue the recreation of such objective as per the current form and not to create a new concept design starting from zero.

In addition to the above, we would like to request for an extension in 90 days submission timeline in order to carry out the documents production in a proper integrated manner. For a better understanding, if we can receive a clear outline of what expectations at this stage of the project. It was mentioned in the documents about Architecture layouts only. Please confirm to avoid abortive works and miscommunication.
