I, A.B., do hereby swear and solemnly and sincerely promise to be faithful to the Republic of Namibia, to uphold and defend the Namibian Constitution and the laws of the Republic of Namibia and to perform my duties as member of the Local Authority Council of Swakopmund diligently, honestly, fairly and to the best of my ability.

So help me God.

(2) A member of a local authority council may, in lieu of an oath, make and subscribe a solemn affirmation in corresponding form.
