- *The City of Cape Town Municipality is also expected to take part in the Games, as they will for part of a sporting alliance which the Part 1 Municipalities intend to form*

All Municipalities are advised to arrive on the **28th of July 2022** at 09:00 at the Jan Wilken Stadium to finalise accreditation on time and attend the opening ceremony.
